

CONFIDENTIALITY AND SECURITY

PublicWin keeps the strict confidentiality in regard to all relations with the Client. Nevertheless, the data may be disclosed to a third party for investigations, if requested by the relevant authority, by a court of law or if the law compels for such purpose, by another public authority and/or if a Client infringes these Terms and Conditions and the PublicWin Regulations.

PublicWin may collect and process private information of the Client or may authorize another company to process such on behalf of PublicWin for the following purposes:

- a. the supply of its gambling and betting services;
- b. reasons of juridical and legal nature;
- c. regulations reasons;
- d. identification and/or authentication; and
- e. marketing purposes.

PublicWin ensures Clients that their private data are always:

- a. processed correctly and according to the legal provisions;
- b. processed in accordance with the rights of the concerned Client;
- c. obtained and processed for a specific legal and limited purpose;
- d. kept and archived in a safe manner;
- e. are not transferred to a jurisdiction that does not observe the above directives; and
- f. used for marketing purposes.

PublicWin assures that one of the following conditions is observed before processing the private data of a Client:

- a. the person explicitly agreed to processing, by accepting the PublicWin Terms and Conditions and Regulations.
- b. we process private data to observe the legal provisions
- c. the regulation authority or any other relevant authority requests from us to process private data in order to approach the administration of justice or legal procedures
- d. in order to protect the Client's interests or such of another person

PublicWin shall not sell, lease, distribute private data of a Client and/or make such available for commercial purposes to a third party, unless the Client previously approved this.

All communications by electronic means between the Client and PublicWin are kept with the evidences for the conformity with the legal regulations.

PublicWin shall keep the private data of the Client and all details related to his/her financial transactions for a minimum term of ten years as of closing his/her PublicWin Account.

The use and/or abuse of an error or a situation of incompleteness on the PublicWin game platform and/or in the downloadable programs and/or in the mobile phone applications and/or in PublicWin Services are illegal. If the account holder detects or finds out about such an error or incompleteness, he is bound:

- a. not to take advantage of the concerned situation;
- b. keep strictly confidential the concerned strict error or incompleteness;
- c. when he/she detects or finds out about such an error or incompleteness, to notify PublicWin by remitting an e-mail at the address suport@publicwin.ro

If the account holder fails to observe this clause, PublicWin:

- a. is entitled to an full indemnity for all costs that may be associated with the error or incompleteness, as well as for the prejudice inflicted by the Client's infringement of this clause;
- b. reserves itself the right especially, without limitation thereto to block the PublicWin Account of the Client and/or fully or partially freeze or reduce the balance of the PublicWin Account, without notification, in order to partially or fully cover the inflicted prejudice or such that is foreseen to be inflicted upon PublicWin.

PublicWin may use the contact data supplied by the Client to notify him about offers, promotions, useful information, novelties.

In accordance with the provisions of the Client's rights, the latter has the possibility to choose not to receive anymore communications from PublicWin on offers, promotions, useful information, novelties.

The data and information supplied and received by the PublicWin website and applications are encrypted by using the Secure Socket Layer (SSL) technology.

PublicWin may use the files of the "Cookie"-type on the website www.publicwin.ro for the following purposes, but without limitation thereto:

- a. To improve the Clients' experience
- b. To save the Clients' preferences
- c. To manage the game sessions
- d. For localization and statistics

By accepting these Terms and Conditions or by using the services, the Client accepts that PublicWin shall use cookie modules.
